Identification:

Each container and packaging shall be clearly labelled. The label shall include at a minimum the manufacturer's name or trademark as well as the ICC-ES PMG certification mark.

Installation:

The Waterproof Membrane shall be installed in accordance with the manufacturer's published instructions and the applicable code(s).

Ceramic tile must comply with ANSI A137.1. Drains shall comply with ASME A112.6.3 or ASME A112.18.2/CSA B125.2 (latest edition) as applicable.

Models:

Waterproof Membrane: Ready to use liquid latex waterproofing membrane applied with brush, roller or trowel for interior use.

Sealing Tape: Composite sheet membrane comprised of an inner layer of polyethylene between two outer layers of polypropylene nonwovens

Conditions of Listing:

1. Application is limited to use as shower sub-pans or lining for showers or tub surrounds in steam rooms and steam showers, bathrooms and commercial and residential kitchens, backsplashes on walls and floors in wet areas.
2. Product is manufactured in Lynchburg, Virginia under a quality control program with annual surveillance inspections by ICC-ES.
